APPLICATION FOR NADA 5-POINT EAR ACUPUNCTURE TRAINING

Acupuncture is a method of treatment that has been used in China for over three thousand years for a variety of ailments. Auricular acupuncture for the treatment of addiction is a relatively recent development in the history of this ancient art. In 1972 a neurosurgeon in Hong Kong discovered that acupuncture alleviated withdrawal symptoms in opiate dependent patients who were undergoing surgical analgesia for other disorders. Over the next twenty-five years this treatment was extensively studied, expanded and improved and is now used successfully in the treatment of all types of drug addictions as well as other behavioral health issues including trauma. Benefits include: reduced cravings for alcohol and drugs, including nicotine; minimization of withdrawal symptoms; increased calmness, better sleep and less agitation; relief from stress and emotional trauma; discovery of inner quiet and strength; easier connection with counseling; and an intention for recovery.

The purpose of this training is to offer an opportunity for healthcare disciplines authorized within their scope of practice in Colorado to become competent in the provision of NADA 5-point ear acupuncture. This includes registered nurses, physicians, acupuncturists, licensed psychologists, licensed social workers, licensed marriage and family therapists, licensed addiction counselors, licensed professional counselors and certified addiction counselor IIIs. The three-day training (9 am to 5pm) will be held **April 25-27, 2014, Friday through Sunday at Fort Lewis College, Durango, Colorado.** A total of 70 hours of training, clinical practice, meetings and homework are required in order to attain a certificate of training from the National Acupuncture Detoxification Association (NADA). The cost will be \$400 for the training. This includes \$100 application fee to NADA for the certificate, training manual and one year membership in NADA.
